Subject: Project Update on G100 Code Refresh Project

Purpose

To provide the Board with an update on the project to refresh the G100 Code of Conduct.

Background

APESB Chairman Kate Spargo and Director Peter Day met with the National Executive of the G100 in March 2012 to discuss matters of mutual interest. At this meeting the following matters were discussed:

- APESB's offer of assistance to the G100 who were about to commence a review of their Code;
- Nomination of G100 representatives to APESB taskforces to develop pronouncements relevant to Members in Business; and
- Establishment of communication protocols between APESB staff and G100 staff to enable progression of matters of mutual interests.

Subsequently, APESB Technical Staff met with the G100 Secretary to discuss the proposed project and to explore ways to collaborate on projects of mutual interests.

In June 2012 APESB Technical Staff and the G100 Secretary met to discuss the Taskforce composition and project objectives.

The Taskforce comprises representatives from the G100 (Tom Pockett, Michael Venter and Stewart Cummins) and APESB (Peter Day – a non-executive director and former CFO and Cath Mulcare – a current CFO) supported by staff (Geoff Harris and Rob Nickel).

The Taskforce first met on 2 November 2012 by teleconference and agreed that, although the principles in the Code are robust, the Code should be rewritten as a contemporary document. The Taskforce also agreed a broad timeline and the basis of its approach. A draft Code was written up and circulated to the G100 Executive for their consideration and to the Taskforce for comment. As of 12 February 2013, comments have been received from all Taskforce members and the proposed Code has been updated to reflect their feedback.
