The roundtables provided stakeholders the opportunity to exchange views on the following:

- International Ethics Standards Board for Accountants' (IESBA's) Exposure Drafts (ED) on:
- Improving the Structure of the Code Phase 2;
- Proposed Revisions to Safeguards in the Code Phase 2; and
- Applicability of Extant Part C to Public Practice.
- APESB's ED on Long Association of Personnel with an Audit or Assurance Client.

The roundtable events were well-attended, with constructive discussion and deliberation amongst participants regarding the APESB's ED and IESBA's EDs. APESB will use the stakeholders' feedback to inform its submissions to the IESBA.

Review of Financial Planning Standard

APESB is undertaking a post-implementation review of APES 230, the standard which covers accountants providing financial planning services. The post implementation review aims to ensure the standard remains relevant in the midst of change in the financial services industry.

The Board is seeking feedback from stakeholders and the community about their experience in implementing APES 230 and any comments relating to the changed environment that may impact on the standard.

Comments on the Consultation Paper: *Post-Implementation Review of APES 230 Financial Planning Services* are requested by 30 June 2017.

APESB issues revised APES 315 Compilation of Financial Information

APESB has issued revised APES 315 Compilation of Financial Information.

The key change in revised APES 315 relates to the updating of the reference in paragraph 1.11 to ASIC Corporations (Audit Relief Instrument) 2016/784 which supersedes ASIC Class Order CO 98/1417 Audit relief for proprietary companies.

The revised standard will be effective for compilation engagements commencing on, or after 1 July 2017 with early adoption permitted.
